This document has legally binding effect! Please read it carefully!

Participation in the game of Paintball requires signing this document! Persons under the age of 16 are only allowed to play if their parents or legal guardians are aware of the conditions and rules of paintball and have read and signed this document.

1. I am aware that Paintball is a dangerous sport in which, despite existing safety rules, various minor, serious, or even the most severe injuries can occur. These are injuries arising from one's own activity (falls, slips...) as well as from the activities of other participants (impact of fired paintballs...). I am fully aware of this and fully assume the risk of such injuries and the payment of any resulting damages. Participation in the game as well as mere observation takes place at one's own responsibility. This means that for any injury I sustain, I waive all compensation claims against the game organizer, leaders, landowner, referees, instructors, and all others connected with the game, and at the same time assume all responsibility for damages including all costs that I may cause to others due to non-compliance with safety rules, negligence, intent, or accident.

If I am required to compensate others for damages caused by me, I waive the right to seek recourse against the above-mentioned entities.

2. I am informed that paintball takes place on uneven terrain, with natural and/or artificial obstacles, where one may run, jump, crouch, crawl... This can result in slips, falls, impacts with branches, and other hazards. There may be stings or injuries from bees, wasps, mosquitoes, ticks, and all other living creatures in nature. I will take care of any safety measures against such injuries myself. Upon being hit by paintballs from markers, impacts to the body occur, which can be painful and may leave redness or bruising. To protect the head from such impacts, it is mandatory to use protective goggles or a mask and clothing. I am also aware that serious and permanent eye injuries (including loss of vision) can occur during a Paintball game. The cause of an accident may be intentional or unintentional firing of a paintball marker. Therefore, I commit to wearing a protective mask with goggles and to following all other safety regulations and measures as well as staff instructions while on the playing field.

I commit to personally or jointly with other perpetrators compensating for any damage I cause during the game on the field. I will also cover all possible legal costs that may arise from my playing of Paintball. I understand and agree that the organizer bears no responsibility in connection with the consequences of any damage or theft of personal belongings I bring to the field (this also applies to personal vehicles and other means of transport).

3. To minimize the possibility of injuries, the following safety rules must be observed:

- a) all markers must have the safety catch activated before and after the game;
- b) markers must always be pointed in a safe direction, away from people, except during the game;
- c) finger may only be on the trigger immediately before firing; otherwise removed from the trigger;
- d) dangerous styles of play must be avoided;
- e) protective goggles/mask must be worn at all times while on the field and within range of markers;
- f) shooting at objects outside the field and at animals is prohibited;
- g) climbing trees is prohibited;
- h) physical contact with other players is prohibited;
- i) setting traps or surprises with other objects, weapons, tools and similar is prohibited;
- j) only approved sports equipment and paint-filled balls may be used on the field;
- k) alcohol and all other intoxicating substances are prohibited;
- l) modifying firing speed or any other part of the marker is prohibited;
- m) bringing dangerous equipment (edged weapons, tools, flammables, pyrotechnics, explosives) is prohibited; all personal equipment must be inspected by the leader;
- n) leaving markers and CO2 canisters in the sun is prohibited;
- o) blind firing is prohibited (only shoot what you can see);
- p) shooting at the referee or leader is prohibited;
- q) shooting at people closer than 5 meters is prohibited (offer them surrender);
- r) verbal orders of referee/leader are final; arguing is prohibited;
- s) intentional destruction of the organizer's property is prohibited;
- t) crossing the marked boundary of the field is prohibited.

A PERSON WHO DOES NOT FOLLOW THESE RULES IS EXCLUDED FROM THE GAME AND MUST IMMEDIATELY LEAVE THE FIELD AND RETURN ALL EQUIPMENT!

4. I confirm that I will adhere to all stated rules regarding safety and the course of the paintball game.

5. I will handle all equipment I use responsibly, carefully, in accordance with regulations, and as a prudent person would.

6. I permit the organizer to use my personal data within the scope of their activities and agree to their publication in media. I also agree to the publication of photographic and audio material created during the Paintball game in media.

I agree with all points of this document and will act in accordance with them. I sign this document entirely voluntarily, without threat or force, in full awareness and good health, being aware of all legal consequences of my decision, without error or deception.
